The course is focused on European economic integration. Main aim is to present the process of European integration in historical context, introduce the current development and outline future of the integration process.

- understand the role of Great Britain in the European integration process,

- explain the factors influencing the current development of European integration process and discuss the possibilities of future development.

- 10. Political and military cooperation in Europe after 1989 new challenges and perspectives.
- 11. Process of integration in the 21st century.
